Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the provisions of section 46 of the Factories Act, 1948 (Central Act 48 of 1948) read with rule 91 of the Kerala Factories Rules, 1957, the names of factories wherein more than two hundred and fifty workers are ordinarily employed have to be notified in the Official Gazette to make applicable the provisions relating to canteen facilities as a statutory requirement. Accordingly, the Government have notified certain factories as per notifications issued under G.O.(Rt.)No. 3596/2000/LBR&REH dated 19th October 2000 and published as S.R.O.No. 1007/2000 in the Kerala gazette Extraordinary No. 1931 dated 27th October, 2000 and G.O.(Rt.) No. 892/2002/LBR dated 22nd April, 2002 and published as S.R.O.No.349/2002 in the Kerala gazette Extraordinary No. 632 dated 13th May, 2002. Thereafter so many new factories have come up and a few numbers of factories have been closed and some others have changed their names. These additions, deletions and changes have to be effected in the notification so as to make it update.

The notification is intended to achieve the above object.
