AND WHEREAS, Government are of the opinion that Safety Officers should be employed in such factories for the safety of the persons employed therein;

Now, THEREFORE, in exercise of the powers conferred by clause (ii) of sub-section (1) of section 40-B of the Factories Act, 1948 (Central Act 63 of 1948), and in suppression of notification issued under G.O. (Rt.) No. 1000/91/LBR & REH, dated 24th April, 1991, and published as S.R.O. No. 685/91 in the Kerala Gazette Extraordinary No. 620 dated 8th May, 1991, the Government of Kerala hereby notify that in every factory mentioned in the Schedule, the occupiers shall employ such number of Safety Officers as specified below, namely:—

Number of workers ordinarily employed in factories	Number of Safety Officers to be employed
Not exceeding 1500	1 (One)
Above 1500 but not exceeding 2500	2 (Two)
Above 2500 but not exceeding 4000	3 (Three)
Above 4000 but not exceeding 5000	4 (Four)
Above 5000	5 (Five)

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the provisions contained in Section 40B of the Factories Act, 1948, the appointment of Safety Officers in certain category of factories is a statutory requirement. But this provision requires statutory notification also. Clause (ii) of sub section (1) of Section 40B of the said Act empowers the State Government to notify factories employing less than 1000 workers in order to make the above section applicable to such factories. Accordingly Government have notified certain factories as per notification issued under G.O.(Rt.) No.1000/91/LBR&REH dated 24th April, 1991 and published as S.R.O. No. 685/91 in the Kerala Gazette Extraordinary No. 620 dated 8th May, 1991. New factories have come up and a few factories were closed down and hence changes have to be effected in the notification, so as to make it up to date.

The notification is intended to achieve the above object.
