

M. R. Sreeletha, Judicial Member:

The applicant's transfer from Neyyatinkara to Irinjalakuda is under challenge in this Original Application. The applicant is an Additional Inspector of Factories under the Factories and Boilers Department.

2. The applicant contends that while he was working in Ernakulam Division he was transferred to Neyyattinkara by order dated 17.06.2019 as part of general transfer proceedings. In 2021 an attempt was made to transfer the applicant to Ernakulam even before completing 2 years service in Neyyattinkara. It was challenged before this Tribunal, and this Tribunal by Annexure-A4 had directed the Government to consider the grievance. By the order issued in compliance, the applicant was retained at Neyyattinkara as Additional Inspector of Factories. It is the case of the applicant that the 2nd respondent is having grudge towards the applicant and therefore he is



now transferred to Irinjalakkda a more distant place, to take vengeance upon the applicant.

- 3. The applicant has completed 4 years of service in the present station. By Annexure-A2 order of transfer, the 4th respondent was posted to his place and according to him, the 4th respondent had not joined pursuant to Annexure-A2 order. The applicant was on factory inspection duty on 26.10.2023 and the transfer of charge could be effected only as per Appendix III of Part I KSR. The applicant being head of office as well as a Gazatted Officer, handing over and taking over of charge could be effected only in the presence of the relieving officer and the relieved officer. As he was on factory inspection, the applicant contends that the taking of charge had not come into effect.
- 4. **Applicant** has raised the following grounds Annexure-A2 transfer order. The reading of Annexure-A2 shows that it was issued considering the request of respondents 5,6 and 7 who are SI. Nos 1,2 and 4. No administrative exigency or any other reasons are shown in Annexure-A2 for effecting transfer. In spite of the existence of norms governing general transfer, no applications were invited for general transfer in the year 2023. The applicant's case is that he could be transferred out of Neyyattinkara only as part of general transfer mandated in GO(P) No. 3/2017/P&ARD proceedings as dated

25.02.2017, through online method. Since the applicant had not completed three years service in the present station, the applicant had not filed application for general transfer in response to Annexure-A3 issued on 28.02.2022. In 2023, no applications were invited for general According to him, the transfer was effected in a highly arbitrary fashion. In order to accommodate the respondents in stations which are convenient and comfortable to them, the applicant was transferred out of Neyyattinkara without even giving him a chance to opt for a convenient station. He also has a case that even a fresh promotee is accommodated in Kottayam while transferring the applicant to a distant place, Irinjalakuda. According to him, there were no reasons for deviating from the general transfer norms and the respondents have not referred to any administrative reason for effecting the transfer of the applicant in Annexure-A2. Had there been a draft list of transfer, the applicant could have got a chance to make So the applicant was ousted from the present post in an options. unceremonial manner as was done by the 2^{nd} respondent in 2021.

5. The official respondents 1 and 2 submit that online general transfer through SPARK was temporarily shutdown due to technical issues. The 2nd respondent had received 3 requests for transfer in the year 2023 from Additional Inspectors of Factories. Both respondents 5 & 6 had requested transfer to Kollam office and both of them applied



on compassionate grounds. The 5th respondent had been working at Kottayam since 2019, whereas the 6th respondent was working in Aluva since 2020. As there was only one vacancy at Kollam, the 5th respondent was posted there and the 6th respondent was accommodated at Thiruvananthapuram.

The 4th respondent and the applicant are working in the office of Additional Inspector Thiruvananthapuram the Neyyattinkara respectively and they have completed more than 4 years of service in Thiruvananthapuram District. The 4th respondent is retiring on superannuation on 30.6.2025 and her home station is Thiruvananthapuram District. Following general transfer norms, the 4th respondent was accommodated in Thiruvananthapuram District at Nevyattinkara. Since the applicant is having 8 years to retire, he was transferred out of Neyyattinkara. The offices of both the applicant as well as 4th respondent are housed on the very same floor of the same building. On transfer, the 6th respondent who was transferred from Aluva to Thiruvanathapuram came to Thiruvananthapuram office for taking charge of the office on 26.10.2023. The 4th respondent who was transferred from Thiruvananthapuram by the same order handed over the charge of Thiruvananthapuram office to the 6th respondent on that date. As the 2 offices of Thiruvanathapuram and Neyyattinkara are functioning in the same room, the 4th respondent could not claim

joining time and she had to take charge of Neyyattinkara office on the same day, ie. 26.10.2023 itself. The applicant was informed by the 4th respondent to come to the office for handing over charge of Neyyattinkara office. As the applicant did not turn up, situation was informed to the 2nd respondent and there upon the 2nd respondent issued Annexure-R2(d) enabling the 4th respondent to assume the charge of Nevvattinkara office. Thus by Annexure-R2(d) proceedings, the 4th respondent assumed the charge of Neyyattinkara office. Otherwise a break in service would have occurred to the 4th respondent. The 2nd respondent has a specific case that the applicant had gone for inspecting a factory even after coming to know about his transfer through official E-mail and Website. No urgent factory inspection was conducted on 26.10.2023 and no emergencies had occurred at Nevvattinkara division and the applicant could have very well attended office, canceling his factory inspection. It is contended that as the order of transfer was published in the Website it was officially communicated to the applicant. The applicant had intentionally left the place in order to avoid the taking of charge by the 4th respondent.

7. In the reply statement filed by then, the respondents 1 & 2 also have a case that the 2^{nd} respondent had found that the applicant was not working efficiently at Neyyattinkara office and due to his inefficiency huge arrears of revenue collection was pending in

Neyyattinkara office as is revealed by Annexure-R2(e). The pending arrears in Neyyattinkara office is the highest in Kollam region. applicant was transferred to Irinjalakuda as there is little amount of pending arrears of revenue collection. In nutshell, the 2nd respondent's stand is that the applicant had completed more than 4 years in Neyyattinkara and he had no right to be retained at Neyyattinkara. He was an inefficient officer and his inefficiency had resulted in large arrears of revenue collection. The 4th respondent is an efficient officer and senior to the applicant who can manage the pending arrears in Neyyattinkara office. Reply Statement also refers to an oral complaint from the office of the Hon'ble Minister against the applicant. There were allegations of accepting bribe from bakery units of the factory and departmental actions were also initiated after conducting an enquiry. It was considering allegations against the applicant that the applicant transferred in 2021. Reference is also made to certain earlier allegations of accepting bribe which had occurred while the applicant was working at Thalassery Division.

8. The respondents 4,5,6 & 7 have also filed reply statement. The 5th respondent has narrated the compassionate grounds which compels her to seek a transfer to Kollam. Her daughter is suffering from Brain and Spinal cord related disorder and is undergoing treatment at Ananthapuri Hospital and Sree Chitra Tirunal Institute for

Medical Sciences. The husband of the applicant is working as Guard in Southern Railway and he has to travel regularly as part of his employment. It was on the above grounds that the 5th respondent had applied for a transfer to Kollam. At the time of request she had completed 4 years service at Kottayam District.



- 9. The 6th respondent in her reply statement points out the compassionate grounds on which she sought a transfer to Kollam. Husband of the 6th respondent is suffering from Polycythemia (clotting of blood) and is undergoing treatment at KIMS Hospital Trivandrum. Mother of the 6th respondent aged 78 years is under the care of the 6th respondent. She is due to retire on 31.05.2026. It was pointing out the above compassionate grounds, the 6th respondent had sought transfer.
- 10. The 7th respondent who is transferred from Irinjalakuda to Aluva contends that she is a resident of Ernakulam and she was working about 70 km away from her residence. She had to take 4 buses to reach her office and she had 2 children aged 19 years and 13 years. The 7th respondent had requested for a transfer and she was accommodated at Aluva considering her request.
- 11. In the reply statement filed by the 4th respondent she contends that she is due to retire from service on 30.6.2025. Her native home town is Thiruvananthapurm and she is the senior most

Additional Factory Inspector in the department with Higher Grade. It was considering the fact that the 4th respondent is having only less than 2 years of service for superannuation, the 4th respondent was accommodated at Thiruvananthapuram. The 6th respondent who was transferred from Aluva to Thiruvananthapuram reported for taking charge on 26.10.2023 and the 4th respondent handed over charge to 6th respondent. As the 4th respondent has no joining time she was bound to take charge on the date of relieving itself. As the applicant was not present in the office she had reported the matter to higher authorities and the 2nd respondent issued orders providing charge to the 4th respondent at Neyyattinkara office.

- 12. Heard both sides.
- judgment of the Hon'ble High Court in OP(KAT) No. 3 /2021 and contends that the transfer norms could not be viewed lightly by the competent authority concerned and the transfer should be subjected to judicial review if it is colored and initiated by malafide. On behalf of the applicant he vehemently contends that the present order of transfer is clearly a malafide exercise of power. It was in order to wreck vengeance on the applicant that the 2nd respondent had transferred him to Irinjalakkuda. The arbitrary exercise of power by the

2nd respondent was interdicted by this Tribunal by Annexure-A4 order

and the same action is repeated by the present transfer is his case.

On the other hand, the learned Government Pleader places reliance on judgment of the Hon'ble Supreme Court reported in (2024 KHC 6135) and contends that Judicial interference is not warranted unless there are clear pleadings regarding malafides or violation of statuary The counsel for the 4th respondent vehemently contends provision. that the applicant had absented himself from the office premises with clear intention of avoiding handing over of charge. He was officially communicated of the transfer order and in spite of that he had gone for factory inspection. The allegation against malafide is not specific. The applicant has alleged the infraction of the procedure, but he has failed to show any prejudice that has occurred to the applicant. The other respondents 5 & 6 have highlighted the compassionate grounds on which they are transferred. The applicant attacks the order of transfer mainly on the ground that it is issued in violation of norms that govern general transfer. It is contended that no applications were invited for effecting general transfer which denied him of his right to exercise option. The official respondents have explained the reasons for not issuing orders of general transfer. There was certain technical defects which necessitated issuance of orders as done in the present case. Though the applicant has raised serious allegations of malafide,

those allegations are not specific and the persons concerned are not

impleaded in the personal capacity. So the allegations of the malafide cannot be given any weight. Though it is contended that the applicant was transferred out in order to wreck vengeance, the applicant has failed to point out any cause for such vengeance and there is absolutely no specific averments on these aspects. The applicant admits that he has completed more than 4 years in the present station. Therefore now he cannot have any right to be retained in the present station, especially when he has more than 8 years to retire. The earlier transfer order was cancelled by the Government on cogent reasons which are totally absent in the present case. At that time the applicant had not completed 3 years in the station and there was a total violation of procedural formalities in the handing over of charge. It was in the above background that this Tribunal directed the Government to consider his case. But in the present case no such ground is made out for interfering with the order of transfer. transfer of 4th respondent was considering the fact that she is on the verge of retirement. The reasons for transferring respondents 5 & 6 accommodating them in Kollam and Thiruvananthapuram and respectively is explained by the official respondents in their affidavits. The 7th respondent had to be accommodated in Ernakulam considering her long service at irinjalakuda and in turn the applicant was

accommodated at Irinjalakuda. In the above facts and circumstances the impugned order of transfer is upheld as no ground is made out for intervention of this Tribunal.

The Original Application is dismissed as devoid of merit.
